

GENERAL COUNCIL CONFERENCE Saturday 6 December 2025

The purpose of the conference is to work together in person to explore the outstanding issues of concern, with the aim of reaching consensus on a final package of governance reforms which could be put to General Council for its consideration and decision at the Annual General Meeting on 25 April 2026.

The programme and timings are as follows:

2pm – 3pm	 Small group workshops (session 2) Co-create refinements (or alternatives) to areas of the proposals where contention remains. Trustee elections x 2 workshops (Groups 3 and 4) Gathering debates x 2 workshops (Groups 1 and 2)
3pm – 3.15pm	Break: Refreshments
3.15pm – 4pm	 Plenary session Share workshop outcomes and build consensus to allow preparation of a final package of proposed reforms in the best interests of the whole charity that would have the support of General Council.

Plenary sessions

During the plenary sessions, we will use several ways to capture your feedback and input. These include:

- Speaking from the floor
- Paper and pens for written contributions
- Slido, a simple tool for live polls, Q&A, and word clouds to make sessions interactive.

Using <u>Slido</u> is easy: all you need is a smartphone or tablet, and there's no need to download an app. Free Wi-Fi is available in the venue and can be accessed without registering for a guest account. If you do not have an electronic device, don't worry – there will be alternative options so everyone can participate fully.

Workshop sessions

For the workshop sessions, Council members will be divided equally into four pre-allocated groups, which will be identified on your name badge, and move to different rooms. There will be an opportunity to be involved in workshops on both the topics.



Conference venue


