- 1. **Introduction and welcome**: Richard Fletcher, Chair of Northumbria Area welcomed members attending.

- 3. **The Minutes** of the 84<sup>th</sup> Annual General Meeting were accepted.
- 4. There were no matters arising.

## **Treasurer's Report:**

- The audited accounts were presented. There was a planned deficit of £1186.09 in line with reducing a funding surplus. The meeting adopted the accounts.
- The understanding is that the current auditor will continue next year.

#### **Access Report:**

- The last stretch of the England Coast Path through Northumberland has been opened. To be renamed King Charles III Way. Some disappointing stretches depart from the coast where conservation issues have had priority.
- The hope is that the entire route through England will be open by the end of this year.
- Storm damage has closed footpaths with a projected 5 year delay in reopening all routes. Ash die-back is also causing problems.
- It was also reported that rural crime has caused gates to be locked which places obstacles for walkers on RoWs. Also that Northumberland plans to maintain its current budget for RoWs.

# Website Report:

- Continuing difficulties in editing the new site makes the inclusion of any information other than that of walks to be impossible.
- A Resolution was called for to require action to make the site more accessible.

The meeting approved all of the above appointments.

Steve Edwards was thanked for his work as Treasurer.

The desirability of having a Countryside Secretary and a Media/Publicity Secretary was stated. It was agreed that the job descriptions would be consulted and discussed at the next AC meeting.

## 8 AOB

- Wendy Maxted requested that any changes of roles within groups should be reported to her in order to keep contacts up to date.
- Display boards will be housed in Gosforth temporarily. Decisions need to be taken about whether or not to keep them.
- The Heritage Way route is well used and comments are favourable. RoW Officers have been very helpful.
- Map library. This resource of 336 maps is currently held by M. McVey. It is used but
  infrequently. Future of the resource could be either that one custodian is willing to take it
  on or that the maps could be given away or that they could be donated to another map
  library. Suggested outlets from the floor were the FitzHugh library of maps at Middleton in
  Teesdale or Oxfam in Durham. W. Maxted offered to take them.
- Training was available for anyone willing to assist visually impaired walkers. It was thought
  that this should not be the responsibility of walks leaders and other issues needed to be
  considered such as getting to and from the start point of the walk when public transport
  may not be available. Anyone interested could contact W. Maxted who would pass on the
  information about training.

Ros Fane from Central Office spoke of the new 10 year Strategic Plan which had been presented and approved at an Extraordinary General Meeting in the Autumn of 2023. This plan aimed to reflect changes in society and funding and to focus on the health and well-being of people who have least access to outdoor activities. The importance of Areas and Groups in delivering the envisaged measures was recognised. In questions following the talk, it was pointed out that disadvantaged communities would find the cost of membership, kit and transport unaffordable. There was no real answer to this problem but Ros noted the remarks.
